Mary Roe called meeting to order at 6:17.

Present were Burns, Vail, Crouch, Elijah, Foster, Augustine, Hynes, Johnson, Jones, Keeney, Lindenberg, Thomas and Roe. Absent were Appleby, Gruner and Addison

The minutes were approved with the correction to be made counting Martha Johnson present. Vote: 12 yes 0 no

Motion to approve the Treasurer's report was voted 12 yes and 0 no.

Burns stated that the newsletter would be coming out in about 10 days.

Special Guest from Parks and Recreation. Mary Roe invited and wanted to recognize two City Parks and Rec employees who were instrumental in getting the Sim's Park Bocce Court and the new lower (child's height) basketball goals installed. Short discussion about the improvement and the added plantings around the Sims Park Building. Mary then presented a plaque to Gary Rich, Recreation Superintendent and Todd Martin, Recreation Department, for their help with the park.



A few suggested upgrades were a sign for Sim Park, down lighting instead of stadium lights and possibly some adult exercise equipment.

Tour of Homes report from Ron Burns. 10% increase in attendance (despite rain). Schools that received funds are AC Moore, Rosewood, Hand and Dreher. Lois Elijah to be SNC representative for the Tour of Homes, 2017.

501c3

The resolution to change SNC to a 501c3 was read by Secretary. A copy of the Resolution " A Resolution of SNC approving the First Amendment to the Council's Incorporation Document..." is included at the end of these minutes.

The motion to approve the amendment to the By-Laws was approved. 12 yes and 0 no.

Heyward/ Harden Triangle Improvement:

George Crouch made a motion to fund improvements the the Triangle.

Motion: I move that the SNC approve an expenditure of "up to" \$7,500.00 to upgrade the shrubbery and planting in the triangle at the corner of Heyward and Harden Streets, subject to the City's approval of an Encroachment and that no contractor will be retained until SNC receives that approval.

Heyward/Harden Triangle Improvement Committee

George Crouch made a motion to create a committee to guide the Triangle Improvements. Committee Motion: I move that we establish a committee of no less than 3 to direct the Triangle Enhancement Project. This committee will be appointed by the SNC president. This committee's will be responsible for soliciting landscape and maintenance companies, at least 3, to bid the project, reviewing the bids and choosing a successful bidder. The committee will also work with the City of Columbia to submit all necessary paperwork for the Encroachment. The successful bidder and bid will be recommended at the next board meeting to occur after the City has approved the Encroachment for approval and to sign a contract.

Several people indicated their interest to be on the committee. Some discussion to authorize the committee to enter into the contract with the successful company rather than having it go before council again for approval. Motion passed 12 yes and 0 no

Shandon Speed Limit

A letter was sent to City Manager, Teresa Wilson , to make 25mph the uniform speed in Shandon. The city's David Brewer is working with DOT to move this project forward. Mary Roe indicated that there is no financial obligation by the Neighborhood for the cost of the signs.

We were encouraged to find some people to serve on council. Next meeting is annual plenary meeting. Voting will take place for new members then. 2 vacancies need to be filled. Russell Jones brought up the discussion about the SNC President-elect position as stated in the by-laws. Currently there is no President elect. However, by-laws state that term for President is one year. That means Mary Roe will not be the President after the next meeting. Conversation went back and forth on two year vs one year term for President. The term President-elect may be changed to Vice-President but that will mean that the by-laws will undergo a vote to change. Russell will continue to work on this and communicate to Council via email.

Some of the street Toppers have been stolen and need to be replaced. Also a possible expansion of the toppers throughout the neighborhood was discussed.

5 Points Update

Amy Beth Franks and Kelly Glenn representing the 5 Points Assoc noted that the St Patrick's Day race has been expanded to include a 15k. This is the 15th year of St Patrick's Day in 5 Points. Suggested that if you have guests coming to your house and the streets have blockade, get with the officer at the blockade and get him a list of names to allow them to drive past the blockade. Shuttle Bus system is also expanding.

Safety Report by Officer Schmidt

Officer Schmidt wanted us to know and all Shandon that for fastest response coontact him directly. His number is on the Shandon Neighborhood website under Safety. A RESOLUTION OF SHANDON NEIGHBORHOOD COUNCIL APPROVING THE FIRST AMENDMENT TO THE COUNCILS INCORPORATION DOCUMENT: AUTHORIZING THE EXECUTION AND DELIVERY OF THE FIRST AMENDMENT: AND OTHER MATTERS RELATING THERETO.

WHEREAS, the provisions the Council wishes to add are incorporated in a document available from the Secretary entitled, "501(c)(3) attachment; and

WHEREAS, the form of the First Amendment to the Incorporation Document, which includes the 501(c)(3) attachment, is attached hereto as Exhibit A.

NOW THEREFORE, pursuant to the authority granted to the Council under the Council's Bylaws and laws of the State of South Carolina, BE IT RESOLVED by the Council,

in meeting duly assembled:

1. Recitals. Each finding or statement of fact set forth in the recitals hereto has been examined and has been found to be in all respects true and correct.

2. First Amendment to the Incorporation Document. The Council hereby

approves the First Amendment to the Incorporation Document in the form of Exhibit A,

approves the execution and delivery thereof, and does hereby authorize the President of the

Council (the "President') to execute and deliver the First Amendment to the Incorporation

Document to the Secretary.

3. Other Powers and Authorities. The President is hereby granted all such powers

and authority to perform such other acts as may be necessary and appropriate to negotiate and

execute the First Amendment to the Incorporation Document and to consummate the transactions

contemplated thereby.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

III. Distributions Upon Dissolution Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (See Article I above), or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
