City Code Enforcement David Hatcher Presenting

Gave details on response to having landlords register their buildings. 9356 registered properties. Thinks there will be 10,000+ properties once all are registered. Shandon has 687 properties listed to date.

Reviewed Code Complaint Procedure. Call and report incident to police. They need to be involved to assign a case for the code infraction. To assess points against the landlord the police report must be on record.

Action on code infraction may take 10-30 days. Be patient.

Safety Report Presenter Officer Schmidt

He pulled stats for the first several months for Shandon. Car break-ins were #1 item. Usually unsecured cars. No burglaries reported in February...but Schmidt was a little skeptical about that

On the subject of Code Enforcement for Landlords...The assessment of points by the code enforcement for rental property needs to have a police case number attached Officer Schmidt stated that he thought our parks were safe. He spends time doing some paperwork in his car while parked outside various parks.

Sims Park Issue

There was an email that circulated regarding inappropriate behaviour at Sims Park. Mary stated that the correct procedure for this type of incident is to contact the police and work with them. It is not SNC's responsibility to "police" activity at the Park. So the point was made these incidents will be handled by the police. And as far as SNC is concerned the incident is now closed.

New Business

Ageing Trees Presenter Mary Roe

Mary stated that Shandon's Tree Canopy is aging. She suggested that the beautification committee investigate some options to replace, prolong life of trees, find funding for projects that involve the trees of Shandon.

The tree trimming was also mentioned. There is an agreement between SCEG and some neighborhoods with Rules of Engagement for trimming the trees.
